- Accident Involvement
- Requests for Reexamination
 - Law Enforcement Requests

Line Exams

- Examiner Screening
- Customer Request

Referral Outcomes

- Issue license
- Require knowledge and road tests
- Sanction driving privileges
- Refer to MAB
- Special permits for driving evaluations

Goals For EMRENS

- Automated referral requests
- Case information in one program
- Identify referrals and outcomes
 - By medical condition, county, etc
 - Track trends in medical conditions and demographics/drivers by county
- Specific training for MVD staff and law enforcement
 - Will help identify drivers who should be referred
- Cognitive screening tool

Demonstration Project -- Key Elements

- Develop, implement, and carry out a year-long demonstration of a new tool, an "Enhanced Medical Referral and Evaluation Management System" [EMREMS], in Iowa.
- In a single database we plan to:
 - Capture all Referrals by source and type
 - Capture all resulting Medical Review processes
 - Capture all Diagnoses and Recommendations
 - Capture all Outcomes
 - Reveal relationships (via query) between Referrals and Outcomes




LEO: What happened to that guy I referred for medical review?

A successful Demonstration Project will ...

- Support greater feedback to Law Enforcement and other referral sources.
- Bolster the value of, and justification for, in-person renewal of vulnerable drivers.
- Enhance the availability of information for operations and for policy development.
- Enhance the responsivity of the medical review system.
- Examine the value of a brief cognitive screen in licensing operations.
- Produce a User Manual and System Maintenance documentation that supports continued use of EMREMS in Iowa, and export to other interested States.

Project Milestones*

- Design EMREMS to allow application within Iowa IT systems (May/June 2013)
- Develop EMREMS software including SDB (Oct/Nov 2013)
- Counter personnel training (April/May 2014)
- Implement EMREMS statewide for one year (May/June 2015)
- Independent evaluation of EMREMS implementation (Oct 2015)
- System documentation and final report (Nov 2015)
