Instructions for Manufactured Home Severed From Real Property

If a manufactured home for which an affidavit of affixation has been recorded is to be severed from real property, the owner shall record and file an affidavit of severance in the jurisdiction in which the real property is located.

The following conditions must apply:

- The manufactured home is no longer attached to a permanent foundation.
- An affidavit of affixation complying with the requirements has been recorded with the clerk of the court of the county in which the parcel of real property to which the manufactured home is affixed is located.

Documents Required

- Completed Affidavit Manufactured Home Severed From Real Property (VR-452). This form MUST be notarized and surrendered to the Circuit Court of the County in which the real property from which a manufactured home is to be severed.
- A statement by an attorney admitted to practice law in the State, or a title insurance producer licensed by the State, that indicates the manufactured home and the real property from which the manufactured home is to be severed are free and clear of any lien, security interest, or encumbrance.
- A certified copy of a recorded affidavit of severance and any supporting documentation that has been filed with the Circuit Court of the county in which the real property from which a manufactured home was located and now severed to be surrendered to the Data Management Division of the Maryland Motor Vehicle Administration at 6601 Ritchie Hwy., N.E., Glen Burnie, MD 21062.

Fee(s)

The clerk of the Circuit Court of the County in which the real property from which a manufactured home is to be severed is located may charge a fee for the recordation.
