- **Application (CS-018)** Provide all information requested on form.
- MD criminal record check authorization form (CS-11) Each form must include a legible copy of the driver's license and an original signature.
- Out of state criminal record check If your rep lives or has recently lived in another state, you must provide a criminal record from that state in addition to the Maryland record check.
- **Photo ID** Once approved, the rep may take the authorization to any MVA full service or express office for issuance.

## **Deleting Reps**

- **Application (CS-018)** Provide all information requested on form.
- **Photo ID** The Rep's photo ID must be returned.
