**Registration Fees:** Vehicles (see reverse side) will be registered for one (1) year at the time they are titled or their registration is renewed. For multiyear registration options, please use myMVA online services.

**Payment Methods:** Visa, Master Card, American Express, Mobile Wallet Pay, Cash, Check and Money Order payable to the MVA. **By Mail:** Check and Money Order only. **Please Note:** The check must include (1) Imprinted name and address, (2) driver's license number (soundex number), (3) home or work telephone number. Company checks must have a Federal Employer Identification Number (FEIN).

**Transferring Plates:** If the annual registration fee is the same or less than the fee for the previously owned vehicle, the transfer fee is \$15.00 plus any difference in the two registration fees. If you are transferring plates and less than 12 months remain before your registration expires, the registration will be renewed for an additional year.

## Registration Fees

In the classes identified below, the cost reflected is for **one (1) year** at time of titling or at the time registration is renewed, but vehicles may also be renewed for two or three years using myMVA online services. Specialty plates may have an additional fee. Fees include the yearly \$40.00 surcharge for the EMS system, where applicable.

### Class E - Truck Fee Schedule

The fee schedule is to be used to calculate fees for both the Gross Vehicle Weight (GVW) or Gross Combination Weight (GCW), whichever is applicable. A surcharge of \$40 and a registration fee increase of \$75 will be added to the final calculation.

### Class E - Farm Trucks

If you intend to operate your farm truck in combination with a trailer that is in excess of 20,000 lbs. GVW, you must select the GCW in increments of 1,000 lbs., as shown above. When operating as a single unit farm truck, you are limited to the GVW. When operating in combination, you are limited to the GCW as selected by you and indicated on your registration. A surcharge of \$40.00 is added to the registration.

### Class G - Farm Trailers/Semi-Trailers/(non-freight)

The annual registration fee is based on the **maximum GCW** of the tractor and trailer, (shown above). A surcharge of \$40.00 is added to the registration fee.

### Class F - Farm Truck Tractors

The **farm truck tractor** annual registration fee is based on the maximum GVW in combination with a trailer or semi-trailer (shown above). A surcharge of \$40.00 is added to the registration.

### Class G - Trailers/Semi-Trailers/ House Trailers (non-freight)

For a **freight** trailer or semi-trailer used in combination with the trucks or trailers, the registration fee is \$58.25 (includes motor freight and farm trailers over 20,000 lbs.)
